### THE DANIEL EVAN ZOTTO MEMORIAL GRANT 2025-2026 ACADEMIC YEAR

**Purpose:** The Daniel Evan Zotto Keeler Grant is offering tuition assistance for college bound and current college students and who are enrolled in an accredited curriculum college course of studies.

Benefit Period: College academic year of 2025-2026

**Award Benefit:** The grant is up to \$500, depending on the number of approved applications, and will be awarded on an annual college year basis. **Grant benefit is for the first four years of undergraduate college education only.** 

**Documentation and eligibility criteria:** Applicant must submit all required documentation. Check each box when you supply the required documents. This sheet must be submitted with the scholarship application.

() Eligibility: Applicant submitting a grant application must be a son, daughter, or grandchild of an active member of the NYSBOC Central Chapter. Active member must be a member in good standing for at least two years of the Central Chapter of the New York State Building Officials Conference and attend at least two NYSBOC Central Chapter meetings annually.
() Academic requirement: must have a grade point average (GPA) of 3.0/B or higher
() <b>Financial proof of funding:</b> Applicant must submit financial statements of all tuition costs for the upcoming academic year from the attending college. No financial statement, no grant award.
() <b>Letters of recommendation:</b> Applicant must submit (2) two letters of recommendation which can be business or personal related.
() <b>Official transcripts:</b> Only official sealed college/high school transcripts bearing the official seal are acceptable and are to be sent no later than August 11th, 2025. No photocopies or faxes will be accepted. Report cards, student schedules, counselor statements, Internet, copies, etc. are not acceptable
<b>Administration:</b> Application must be made to the committee for the fall 2025 and spring 2026 semester. All require documentation must be postmarked no later than August 11th, 2025. Recipients will be notified as soon as possible of grant approval. Funding will be forwarded to the applicant as soon as possible. Recipients may have their name and/or photo used by the Central Chapter of NYSBOC for media uses. This page must be submitted with the application.
